**Since January 2016 it is now law that you MUST transfer ownership of a horse within 30 days of the purchase. Failure to do so can incur a £2000 fine.**

Whenever you buy a Quarter Horse the breeder or owner should ALWAYS give you the Horses Passport AND the AQHA Certificate of Registration (Pure bred). We strongly recommend that you also ask for a bill or sale that both you and the seller sign.

Send the Passport, this form and a COPY of the AQHA (USA) Certificate of Registration. This will be in the previous owner name. Once you have the horse registered in YOUR name with USA, Email a copy to, [info@aqha.uk.co.uk](mailto:info@aqha.uk.co.uk)

### **HOW TO PAY**
